

**CRITERIA 6:** Children living with (a) parent(s)\* / carer(s)\* who is / are committed to a Christian\*\* Church in communion with the Anglican Church or the Catholic Faith with the application supported by a Priest's / Minister's Reference Form, completed by the Priest / Minister who will return it directly to the school. The parent'(s)' / carer'(s)' attendance at the church must currently take place at least twice per month for a minimum of two years and the application is to be supported by a Priest's / Minister's Reference Form, completed by the Priest / Minister who will return it directly to the school. The Supplementary Information Form will be returned directly to the school. Within this category, priority is given to families where (a) sibling(s) is / are currently attending Holy Trinity Church of England Primary School.

\*A "Christian Church" is deemed to be an Anglican Church or church or chapel of a Christian Denomination affiliated nationally to 'Churches Together in Britain and Ireland' or Evangelical Alliance.
